Our Abilities Community Services group is in week 5 of provincial bargaining and we will be beginning TAPS bargaining later this spring.

- Our Recording Secretary gave notice she is stepping down

We are still awaiting a proposal from the building owner for a new lease, but we finally had someone come and install the new window, which is great.

We have one outstanding grievance, waiting on a ruling. We have a few potential ones that haven't been written up yet, so not officially filed. As well, we will have a couple to deal with Vaccine Policies and people on unpaid leaves. There are long waits for arbitration at this time.
